We are writing to provide an update on the recent bargaining sessions held with the Company on February 6, 7, and 8<sup>th</sup>, 2024. As you may recall from our last Power Notes, we communicated that there were some differences in our positions. Unfortunately, after the latest sessions, these differences have become more pronounced.

Our Bargaining Team has been working tirelessly, conducting extensive research, and crafting a bargaining package developed using the survey results from our members. This package reflects the current industry state and addresses the economic conditions our members have weathered over the past several years.

#### **"YOUR HARD WORK DESERVES RESPECT"**

Given the current situation, and with a clear understanding of the importance of these negotiations, the Bargaining Committee has made the strategic decision to pause the February 13 & 14<sup>th</sup> bargaining sessions to consult with the Union's legal representation. This decision is not taken lightly; however, we are committed to ensuring that our resources are used effectively and not expended on discussions that do not yield progress towards a Memorandum of Agreement. Bargaining dates are scheduled for February 20, 21 & 22<sup>nd</sup>, March 12, 13, 14<sup>th</sup>, and March 25, 26<sup>th</sup>, 2024.

We will continue to keep you updated as the bargaining process progresses. As always, we are here to listen to your concerns and answer any questions you may have. Please do not hesitate to reach out to the Business Office or any member of your Bargaining Team.

We appreciate your patience and understanding during this time and would like to thank you for your continued dedication and hard work. Together, we will continue to strive for a fair and equitable workplace for all.
